Organizational Leadership

- Led the organization through a period of internal upheaval, professionalizing the staffing structure, regaining 501(c)3 status, diversifying fundraising, and establishing operational policies.
- Wrote and secured a \$670K federal grant for FY2025, the first in the organization's 30+ year history, which grew the annual budget from \$250K to over \$1M.
- Rebuilt strategic relationships with the Pentagon, White House, Congress, and national military/veteran and LGBTQ+ advocacy organizations.

Advocacy & Policy

- Provided written testimony and presented advocacy priorities to lawmakers in the House and Senate Armed Services and Veterans' Affairs Committees.
- Worked with lawmakers to successfully pass laws and policies that improve the well-being of LGBTQ+ and HIV-positive communities (e.g., worked with Senator Jeff Merkley's office to pass a resolution recognizing September 20th as LGBTQ+ Veterans Day).
- Successfully changed DoDEA policies, provided cultural competency training to 2,600 military family life counselors, and worked with the Offices of the Acting Secretary of Defense to support HIV+ service members and the "Don't Ask, Don't Tell" Records Review Initiative.

Program Development

- Built and implemented new programs, including the "Resilient Heroes" suicide prevention program, "Modern Military Strong Communities" in partnership with PFLAG, a transgender legal services pro bono attorney network, and a grassroots advocacy training series.
- Created an LGBTQ+ and HIV discrimination reporting form to track concerns within the worldwide U.S. military and veteran community.
- Updated and expanded the organization's LGBTQ+ cultural competency training series using a successful fee-for-service model.

Communications & Fundraising

- Served as the primary media spokesperson, responding to print, video, and radio requests from regional, national, and international news sources.
- Built and implemented rapid response media protocols for anti-equality legislation.
- Expanded readership of the organization's award-winning magazine 100-fold by transitioning from print-only to an online platform.
- Oversaw a donor database transition and the creation of a HIPAAcompliant database for mental health and legal service programs.
- Implemented a Google Ads grant to expand organizational visibility on owned and paid media.

Organizational Leadership
